# Mapefloor Cleaner ED

**Detergent for routine degreasing operations of floors**

## WHERE TO USE

**Mapefloor Cleaner ED** is suitable in all those cases where a strong detergent is required on surfaces which are not subject to damage by water. It has been specially developed for cleaning resin floors, such as the **Mapefloor System**, and leaves a clean, shiny finish on the floor surface.

## Some application examples

- Cleaning treatment for resin floors made using the **Mapefloor System** inside environment for civil, public and industrial use.
- Cleaning treatment for protective films on decorative floors made using **Ultratop**, including those mixed with **Dynastone Color** or natural aggregates, in environments for civil use such as showrooms, shops and apartments.

## TECHNICAL CHARACTERISTICS

**Mapefloor Cleaner ED** is a concentrated water-soluble product made of a special mixture of surfactant, low-foaming components, for cleaning greasy stains from washable surfaces and floors subject to heavy traffic. The action of the surfactant components is completed by the solvent and deodorising action of the terpinolene contained in the product. The product contains a minimum of 90% of bio-degradable surfactant components.

## HOW TO USE

The product may be used by hand or with mechanical cleaning means.

Use **Mapefloor Cleaner ED** at a concentration of 1-3% (100-300 g in 10 litres of water).

Increase the concentration according to requirements on porous or heavily soiled surfaces.

## PACKAGING

**Mapefloor Cleaner ED** is available in 10 kg cans.

## STORAGE

**Mapefloor Cleaner ED** can be stored for 12 months in its original packaging at a temperature between +10°C and +30°C. Protect from frost.

## SAFETY INSTRUCTIONS FOR PREPARATION AND APPLICATION

**Mapefloor Cleaner ED** is not considered a dangerous substance according to current norms and regulations regarding the classification of preparations.

The use of protective gloves and goggles and the application of the usual precautions taken when handling chemical products are recommended.
